



NC Injury Law Receives Super Lawyers Nomination Recognition

NC Injury Law, PLLC has received recognition through the Super Lawyers nomination process, a peer-review evaluation system administered by Thomson Reuters that assesses attorneys across 12 indicators of professional achievement and peer recognition. The nomination highlights the firm's standing within North Carolina's personal injury legal community while the practice continues expanding representation for serious injury victims throughout Wilmington and the coastal region.

The Super Lawyers nomination process evaluates attorneys through peer nominations, independent research, and peer evaluations, with no more than 5 percent of attorneys in each state ultimately selected to the Super Lawyers list and no more than 2.5 percent selected to the Rising Stars list. The NC Injury Law Super Lawyers Nomination represents meaningful recognition within the state's competitive personal injury legal landscape.

The firm represents injury victims throughout Wilmington, New Hanover County, Brunswick County, and Pender County, a tri-county region that recorded more than 20,000 traffic crashes and approximately 130 fatalities in the most recent five-year North Carolina Department of Transportation reporting period. The

practice provides bilingual English and Spanish representation, addressing language access barriers that can prevent injured victims from understanding their rights under North Carolina's strict contributory negligence framework.

"The Super Lawyers Nomination reflects how fellow North Carolina attorneys evaluate our advocacy, which ultimately determines whether clients receive the representation needed to navigate contributory negligence arguments and insurance defense teams," said a spokesperson for NC Injury Law. "For Wilmington's Latino community, language barriers can reduce understanding of rights at exactly the moment when making statements to insurance adjusters is most consequential. Our bilingual service ensures that language access never compromises a victim's ability to protect their claim."

The firm's geographic focus includes some of North Carolina's most dangerous transportation corridors. The Port of Wilmington, one of the busiest cargo facilities on the East Coast, generates constant commercial truck traffic on US-17, NC-133, I-140, Burnett Boulevard, and Shipyard Boulevard. These freight corridors create recurring multi-party liability scenarios for truck accident victims that require Federal Motor Carrier Safety Administration-regulated evidence preservation and multi-defendant claim strategies.

North Carolina's contributory negligence rule eliminates all recovery if the injured victim is found even 1 percent at fault, making experienced legal representation from the first day after an accident the most critical factor in whether a personal injury victim recovers full compensation or nothing at all. The state recorded more than 273,000 total traffic crashes in a recent reporting year, with personal injury claims involving traumatic brain injury, spinal cord damage, and permanent disability generating cases requiring the most experienced legal advocacy.
